1.0 INTRODUCTION

hell Nigeria Exploration and Production Company began offshore activities in 1993 with the objectives of discovering and producing hydrocarbons from Nigeria's frontier areas and a vision of becoming Africa's leading deep water Oil and Gas Company.

Over the years, SNEPCO as a corporate citizen has contributed immensely to the socioeconomic development of the nation through its various social investments covering almost all sectors of the economy. This is in tandem with its vision of 'Giving Something back to the communities- (Nation) where they operate'

SNEPCO is currently fine tuning its next phase of social investments across the 6 Geopolitical Zones of the country. In a bid to develop and implement people-oriented programmes attuned to the Socio-Economic realities of the selected States; SNEPCO has commissioned a Sectoral Need Assessment Survey covering the following sectors:

- Education
- Health Delivery Services
- Cottage Industry Support
- Capacity Enhancement for Economic Empowerment for Women and Youths.

To this end Optimum Resources Management- a leading firm of management Consultants and Advisors was selected to conduct the assessment in the Northern Zone comprising of Katsina state (North Central), FCT- Satellite towns (Federal Capital Territory), Katsina State (North West) and Taraba State (North East).

Below is the terms of reference for the need assessment.

- Conduct needs assessment survey on the following sectors (Health, Education, Youth/Women Development, Cottage industry) in selected States from the country's geo-political zones.
- This will involve collecting, collation and analysis of baseline information in sample study areas. A baseline survey will broadly assist in providing an idea of project impacts based on a comparison of pre and post project situation in study areas. Survey results should be representative of the critical needs of the generality of the public/community in the focused sector areas.

- Draw up a plan of action and timetable for accomplishing the various components of the consultancy including interviews, focus group meetings and other field activities including reporting.
- Establish and document from official records of key institutions, state government, relevant ministries, other government agencies including local government authority, their short, medium and long term development agenda in the focus areas.
- Engage various stakeholders of relevance in different sectors of the state in generating generic and specific needs to be addressed.
- Consolidate findings from selected relevant institutions, local and state governments and rank in order of priorities.
- Engage in a state-level workshop to generate action plans in response to identified needs.
- Generate concept notes on education, health, capacity enhancement/economic empowerment programs and cottage industry support needs.
- Identify partnership possibilities in execution of identified projects for the sectors.
- Identify for focused sectors the best sustainable socio-economic projects that can be executed to address the identified gaps.
- Develop a 5 year social intervention plan for the State where assessment is made and Within 8 weeks of engagement, submit comprehensive reports (hardcopies and electronic) of findings and propose practical recommendations.

1.1 STUDY OBJECTIVES

The objective was to participatorily determine critical development needs of the selected States of Kwara, FCT, Katsina and Taraba in the areas of:

- (a) Health Delivery
- (b) Education
- (c) Cottage Industry Support and
- (d) Capacity enhancement for Economic Empowerment (Women & Men)

And to formulate a 5- year Development plan after validating needs with a broad spectrum of Stakeholders across the selected sectors.

1.2 STUDY METHODOLOGY

To achieve the objectives of the needs assessment, a variety of survey methods were deployed as follows:

i. Desk Research/Literature

A well long desk research/literature review was carried out for each of the selected States. The aim of the desk research was to:

- Capture baseline information on States and focus areas
- Identify existing problems and challenges in the States and focal sectors
- Identify opportunities for Partnership
- Gather relevant information necessary for the development of survey instrument

ii. SAMPLING

Purposive sampling of relevant stakeholders in both public and private sectors was done. This involved Ministries, Department and Agencies (MDAs) related to our focus sectors- Health Delivery, Education, Cottage Industry and Capacity Enhancement for Economic Empowerment and on the basis of this a respondent target sampling frame and guide (See Appendix 7) was developed.

iii. SURVEY METHOD

A combination of data collection methods were used to elicit information from the respondents across the focus sectors. This included Questionnaire Administration, Interview, Focus Group Discussion, Key Informant Interview and visit to parent Ministries of Education, Health, Commerce & Industry, Youths & Sports Development, Women Affairs etc of the participating States.

Pre-tested structured questionnaire was designed and shared with SNEPCO for inputs and criticism. The structured questionnaire was the main data collection instrument supported with semi-intensive interview guides for focused group discussion.

A one day participatory workshop was also organized in each State to validate and prioritized identified sectoral needs. This was to promote broad based participation and ownership of the process leading to the development of sector-based action plans and 5-year development plans.

A 2-day pre-data collection training was done for Subject Matter Specialists/ Enumerators in each of the participating states prior to the commencement of the data collection. Some of the topics covered during the training includes:

- Concept of sectoral needs assessment
- Understanding baseline data/policy document and plans
- Communication and interviewing skills
- Organizing Focused Group Discussion
- Participatory workshop in data collection
- H.S.E
- Field Reporting/Note taking
- Review of questionnaire, role play and practical discussion

The subject matter Specialists/Enumerators were formed into State team each lead by a team Leader

1.3 DATA COLLECTION

Two main data types were collected. Primary and Secondary data. The Primary data were collected using the structured questionnaire with supplementary information from both the FGD and Key Informant Interview.

The Secondary data were information gathered from relevant MDAs related to the focus sectors. They include policy document, development strategies and plans.

Given limited time available for the survey, a total of 30 questionnaire were administered per focus sector except for Capacity Enhancement for Economic Empowerment were 20 questionnaire each were distributed for both Youths and Women.

The use of the developed sampling frame/guide (See Appendix 7) ensured that a broad spectrum of the Stakeholders in each sectors were interviewed in the rapid needs assessment process. Data were collected within a time range 7-10 days before the validation workshop and one additional week after the validation exercise.

Out of the strategically relevant Stakeholders interviewed per sector, 7 of them adjudged to be very knowledgeable and resourceful in the subject matter area (focus sectors) were invited for the validation workshop in a ratio of 4 men and 3 women to ensure gender balance.

Stakeholders Validation Workshop

To promote participation and ownership of the process leading to the development of the 5 year development plan and concept notes, one day workshop was organized in each of the States.

In Katsina state, the Validation Workshop was held at the conference Hall of the State Library Board. A total of 24 people attended the workshop(See Appendix 7)

A summary of activities at the workshop (See Appendix 8/ Stakeholders Workshop Programme) include:

- Presentation of identified critical sector needs
- Validation of findings
- Prioritization of identified sector needs at the plenary
- Selection of 5-7 critical sector needs for action plan development
- Development of action plan per sector
- Evolution of a 5-year development plan per sector. This could not be achieved in most center due to the constraint of time and the ongoing Ramadan fast at the time

1.4 DATA COLLECTION CONSTRAINTS

A number of challenges were encountered in the course of conducting the survey. These include the following;

- 1. The security challenges in the Northern part of Nigeria threatened free attendance of some persons invited for the validation/planning workshop across the states
- 2. Insufficient time was allowed for the conduct of this survey
- 3. It was a bit difficult to get salient information from some MDAs of the state government. Some of these respondents did not feel comfortable given out some information to the research team with the fear that the political opponents of the state government may use such data against them. Some others simply expressed their disenchantment in completing the questionnaires on the ground that they have seen people and agencies come for such assessment exercises in the past but failed to implement their findings at the end.
- 4. Some respondents demanded to be paid as condition to participating in interview
- 5. Some MDAs demanded for full disclosure of the funding agency and letters of authorizations

However, the degree of occurrence of these limitations was very insignificant to affect the credibility and reliability of data garnered in the study.

1.5 DATA ANALYSIS & INTERPRETATION

1. Respondent Response Rate

About 78% response rate was achieved. This is not unconnected with the short data collection duration and the ongoing Ramadan fast at the time in most of the Northern States.

2. Data Analysis

The returned questionnaire and responses to interview guide and focused group discussion were first collated into the focus sectors:

- o Health Delivery
- o Education
- Cottage Industry Support
- Capacity Building for Economic Empowerment (Youths)
- o Capacity Building for Economic Empowerment (Women)

The data were then analyzed using simple descriptive statistics of frequency and tabulations.

1.6 Background and study area

Taraba State is a state of Nigeria, named after the Taraba River which traverses the southern part of the state. Taraba's capital is Jalingo. The state was created out of the former Gongola State on 27 August 1991, by the military government of General Ibrahim Babangida. The state was created on 27th August, 1991, along with eight other states. The state creation exercise was the result of a continuing process of socio-political devolution, which started in 1963, to make Nigeria a politically stable and economically strong country.

Taraba State, with its numerous small ethnic groups and remote location, was a particularly neglected and grossly underdeveloped part of the former Gongola State. Because of its rugged topography, lack of access roads from other parts of the country, and indeed, the neglect it suffered from past administrations, the state still remains largely peripheral to the nation's economic and political life.

The need to diffuse centers of economic growth and draw the peripheral population into the mainstream of the nation's economy, which are among the important reasons adduced to justify state creation exercises in the country, are therefore most relevant to Taraba State.

With an estimated land area of about 54,428 sq. km, the state lies roughly between latitudes 6Ű25'N and 9Ű30'N and between longitudes 9Ű30'E and 11Ű45'E. Taraba State is bounded in the west by Plateau and Benue States and on the east by the Cameroon. It has sixteen Local Government Areas, which are governed by elected chairmen. They are as follows: Ardo, Kola, Bali, Donga, Gashaka, Gassol, Ibi, Jalingo, Karim, Lamido, Kurmi, Lau, Sarduana, Takum, Ussa, Wukari, Yorro and Zing. Aside Ardo Kola, Kurmi and Ussa LGAs which were created in 1996 out of Bali, Takum, and Jalingo LGAs respectively, others have been in existence since 1991.

These Local government structures are further subdivided into eighteen district areas. The district areas are units based essentially on cultural factors which seek to emphasize ethnic circumstances. Unlike the local government units which officially operate and are recognized as the third tier of government, the districts are administered traditionally through a hierarchy of chiefs, village and ward heads.

The traditional setup of the district level administration serves as an important linkage between the grassroots population and the local government administration. This arrangement, though not sufficiently exploited yet, has no doubt helped to enhance peace and harmony among the various ethnic groups in the state.

Perhaps it may be necessary to allude that the future spatial planning for development in Taraba State should encourage the reemergence and proper integration of the districts or a system of development areas in each local government area, as an integral part of a grassroots based development strategy that recognizes the fourth dimension administrative structure.

Taraba State lies largely within the middle of Nigeria and consists of undulating landscape dotted with a few mountainous features. These include the scenic and prominent Mambilla Plateau. The state lies largely within the tropical zone and has a vegetation of low forest in the southern part and grassland in

the northern part. The Mambilla Plateau with an altitude of 1,800 meters (6000 ft) above sea level has a temperate climate all year round.

Rivers Benue, Donga Traba and Ibi are the main rivers in the state. They rise from the Cameroonian mountains, straining almost the entire length of the state in the North and South direction to link up with the River Niger.

The major occupation of the people of Taraba State is agriculture. Cash crops produced in the state include coffee, tea, groundnuts and cotton. Crops such as maize, rice, sorghum, millet, cassava and yam are also produced in commercial quantity. In addition, cattle, sheep and goats are reared in large numbers, especially on the Manbilla Plateau, and along the Benue and Taraba valleys. Similarly, the people undertake other livestock production activities like poultry production, rabbit breeding and pig farming in fairly large scale. Communities living on the banks of River Benue, River Taraba, River Donga and Ibi engage in fishing all year round. Other occupational activities such as pottery, cloth-weaving, dyeing, mat-making, carving, embroidery and blacksmithing are also carried out in various parts of the State.

In terms of ethnic composition and culture, Taraba is a highly heterogeneous, multiethnic state with close to eighty indigenous ethnic groups speaking different languages. Some of these groups are too small numerically, thus posing the problem of political insignificance in a democratic polity.

These are manifested in their general behaviour, social values, fashion, art and craft, dances, songs and musical instruments. Accordingly, there are a variety of cultural festivals mostly performed to mark harvest, initiation into manhood or womanhood, installation of rulers, marriage, burial ceremony and general entertainment.

Prominent among the major cultural festivals are the Nwunyo Fishing Festival in Ibi (Ibi Local Government Area), the Purma of the Chamba in Donga (Donga LGA), Puje of the Jukuns (Wukari LGA), Sharo of the Fulanis in Jalingo, ArdoKola, Lau and Bali LGAs, Kuchicheb festival of the Kutebs in Takum LGA, Kati of the Mambilla in Sardauna LGA, and Mantau and NseNse festivals of the Mumuye people in Pantisawa, (Yorro and Zing LGA).

Traditional dances performed by the people include Mazawaje in Kurimi (Kurmi LGA), Lera in Donga, Bali and Takum LGAs; Akishe and Goge dances in Wukari LGA, Nyawata in ArdoKola, Jalingo, Bali and Lau, and the Ichen dance in Donga and Bali. The Adire and Tsakekke cloth (a handwoven and dyed dress) worn by both males and females during festivals are important part of the culture of the Jukuns and Fulanis in Taraba State.

The government has made concerted efforts to improve areas of tourist attractions like Mambilla Tourist Center, Gumpti Park and game reserve in Gashaka; and the Nwunyu Fishing festival in Ibi, which is usually held in April of each year where activities such as canoe racing, swimming competition and cultural dances are held. Other festivals are Purma of the Chamba in Donga, Takum and Bali, the Puje of Jukuns, Kuchecheb of Kutebs in Takum and Ussa, Kati of the Mambilla and host of others. Taraba is called "Nature's gift to the nation" as the state is rich and have many ethnic groups, including Jenjo, Kuteb Chamba, Mumuyes, Mambila, Wurkums, Fulanis, Junkun, Ichen, Tiv, Hausa and Ndoro.

Ecologically, the state may be divided into three topographic regions. West of the River Benue, covering mostly Ibi and Karim Lamido Local Government Areas, are the extensive Fadama swamps of the Muri plains. This region is very thinly settled and virtually uncultivated.

A marked contrast to the floodplains is the undulating lowland of the eastern Muri plains. This is broken intermittently by high rising hills such as the Kungana, Fali and Bali hills which developed on sandstones. Standing above the 350m contour, the hills are developed on both sedimentary and crystalline rocks.

Usually, hills on sedimentary formations tend to have flat tops due most probably to lateritic capping. On the other hand, the hills which s developed on crystalline rocks consist of dome shaped inselbergs. The Mambilla Plateau is a unique topographic region with some of the largest and highest mountains in Nigeria, with peaks reaching over 1840m. The Chabbal Hendu, for example, is over 2000m above sea level.

The Plateau which developed on basement complex rocks, measures about 96km along its curved length and 40km wide, and bounded by an escarpment which is about 900m high in some places. The Mambilla Plateau forms the watershed from which the major drainage systems in Taraba State take their source. Rivers Benue, Donga and Taraba (from which the state derives its name) are the dominant drainage systems which flow across the Muri plains to drain the entire state.

Together with the minor ones, such as the Lamorde and Mayo Randewo, they form extensive flood plains in the central part of the state, providing sufficiently fertile agricultural land which is presently underutilized. The undulating hilly surface of the plateau is uniquely attractive for its scenic beauty.

The basket of egg-like surface of the plateau with its blend of evergreen low growing grass vegetation, neatly demarcated into some kind of ranches/grazing reserves, and the sharply meandering road with hairpin corners across hill slopes, ravines and deep gorges, make driving to and from the plateau most astounding and interesting to a visitor.

In terms of, like most parts of northern Nigeria, Taraba State has a wet and dry climate. The wet season lasts, on the average, from April to October. Mean annual rainfall varies between 1058mm in the north around Jalingo and Zing, to over 1300mm in the South around Serti and Takum. The wettest months are August and September.

The dry season lasts from November to March. The driest months are December and January with relative humidity dropping to about 15 percent. Mean annual temperature around Jalingo is about 28°C with maximum temperatures varying between 30°C and 39.4°C. The minimum temperatures range between 15°C to 23°C. The Mambilla plateau has climatic characteristics typical of a temperate climate.

Temperatures are low throughout the year and the rainy season lasts from February to November with a mean annual rainfall of over 1850mm. In the area of vegetation, rainfall distribution and topography are the most important factors influencing the pattern of vegetation in Taraba State. The vegetation may be classified into three broad types: the Northern Guinea, the Southern Guinea and the Mountain Grassland and forest vegetation.

The boundary between the Northern Guinea and Southern Guinea corresponds fairly closely with the 1400mm mean annual rainfall isohyet, while the mountain forest and grassland vegetation occur mainly on the Mambilla plateau. Most of the lowland area is made up of ferruginous tropical soils which developed on crystalline acid rocks and sandy parent materials. The upland areas, especially the Mambilla Plateau, are covered by humic ferrosols and lithosols which are highly weathered and markedly lateritised, due to leaching.

Excessive deliberate bush burning, soil erosion, desertification and river blindness (onchocerciasis) are among the most adverse ecological problems in the state. From December to February (during the peak of the dry Harmattan season), a large part of the natural vegetation especially in the northern part of the state, is easily turned into an ash laden, dark looking wilderness of burnt vegetation, posing serious threat to livestock rearing activities in the state. Bush burning, fuel-wood exploitation and the traditional slash and bum agriculture practiced by the peasant farmers are gradually but consistently causing desertification and soil erosion especially in the northern part of the state.

River blindness is another major environmental problem in the state. Onchocerciasis is particularly a serious health hazard in the Gashaka, Bakundi and Gassol districts. It is a form of filariat disease caused by a nematode (fly) called Onchocerca volvulus. The vector (called the black fly), takes advantage of the fast-flowing sections of rivers, such as rapids or rock surfaces, as breeding grounds.

Such conditions are provided by River Taraba which in fact traverses the three districts of Gashaka, Bukundi and Gassol, in the Gashaka, Bali, and Gassol LGAs. It has been speculated that the Taraba river valley may be one of the worst Onchocerciasis zones in West Africa. The socioeconomic consequences of onchocerciasis on the people of Taraba State are enormous.

The disease has affected between three to forty-eight percent of the productive age groups of the population living near the river valleys in these districts. It also reduces the economic productivity of the rural dwellers and undermines primary school enrolment and school attendance. In many cases, it results in the complete abandonment of a whole village for fear of the disease.

The Federal Ministry of Health and the state government, in collaboration with AFRICARE (an international non-governmental organisation), are, however, working seriously to control the incidence and reduce the effects of onchocerciasis in Taraba State. While measures taken so far are mainly directed at attacking the direct causal agent of the disease, the focus of government in the new millennium should also be directed primarily at environmental education, awareness and control within the affected communities.

Population Structure and Distribution: From the final result of the 1991 population census, Taraba State is populated by 1,946,156 people (1999 projected). The gender population disparity of 0.6 percent is fairly low. With an estimated land area of about 61,368.8sq. km., the state has a population density of 24.6 persons/sq. km. The state's population is highly juvenile in structure.

The less productive population in the 019 age group account for about 56.2 per cent of the population, while 72.8 percent are aged between 029 years. The implication is that the state will have to invest heavily on providing for the health and educational development of its youthful population. About 5.3 percent of the populations are above the official retirement age of sixty years. In other words, the most productive age group (i.e. thirty to fifty-nine years) constitute only 21,9 per cent.

Urban and Rural Settlement: By all standards, Taraba State is predominantly rural. Based on the 1999 projected population of the major settlements in the state, only about 11.6 per cent of the state's populations live in four towns with population exceeding 20,000.

If urban settlements are defined as those places with over 20,000 inhabitants, then the typically rural nature of the state can be appreciated. On the other hand, there are only eleven settlements with population ranging between 10,000-20,000 inhabitants and which can best be described as small towns.

Taraba State inherited from the former Gongola State only rudiments of what can be described as indices of development. Most social infrastructure like educational institutions, health facilities, roads network, electricity supply, etc, are grossly inadequate and where available, are poorly developed and substandard. In most cases, they are found in the urban places.

Taraba remains one of the least developed states in Nigeria, not because it lacks the natural and human resources to develop. Its backwardness may be linked more to the problems of improper planning. Even where there is little planning, lack of proper and disciplined plan implementation, monitoring and evaluation by past governments had consistently resulted in misapplication of scarce resources for development.

Industrial investments are grossly lacking; rural and urban markets are poorly developed; transport facilities were on the verge of total collapse until the PTF intervention; schools and the entire educational sector are neglected seriously and dilapidated, health facilities are grossly inadequate and inefficient.

The general insensitivity of past governments to the ample development potentials and needs of the state have no doubt placed Taraba in a condition of abject poverty and economic backwardness which future administrations especially, the democratic system, must redress. This requires proper planning and application of the state's human and natural resources to the development process.

Education: The stock of educational institutions, especially at the lower level, appears not to be uniformly provided in terms of their number. There are a total of 986 public primary schools with a total enrolment of about 561,037 pupils distributed among the 16 local government areas of the state, with a mean of sixty two primary schools and a range of 123.

This indicates a very high spatial inequality in the level of provision of primary schools. Eight out of the sixteen local government areas have more than the average number of primary schools. Ardo Kola, Bali, Ashaka, Ibi, Jalingo, Kurmi, Yorro and Zing have less than the mean number. The local government with the largest number of primary schools is Sardauna (132) while Ashaka has only sixteen schools.

Based on the projected 1999 population of the state, 79.7 per cent of the children of school age enrolled in the primary schools. However, the quality of the services rendered may be anything but satisfactory. The students-teacher ratio which ranges between 25 188 students to a teacher in the state's 109 secondary schools is among the highest in the country.

The current students' population of 113,497 in the state's fifty-six secondary schools represents only about 20.23 per cent of the population of secondary school aged children. The problem of female education, as reflected in the pattern of school enrolment, appears to be more acute at the secondary

school level. According to the final results of the 1991 population census, 64.5 per cent of the state's populations are illiterates. More seriously, the level of female illiteracy (about 75.1 per cent) is probably the highest in the country.

Health Services: There are only eight Government-owned General Hospitals located at Jalingo, Takum, Bali, Gembu, Zing, Bambur, Warwar and Wukari, serving about 1.94 million people in the state. There are about 589 other medical establishments providing primary and maternal health care services in the state.

About 70,8 percent of all the health establishments are owned by the local governments while private and Mission-owned establishments constitute 27.6 per cent. Only 0.33 per cent and twelve per cent of the health facilities are Federal and State government investments, respectively. With only thirty-four medical doctors and a total of 1,156 hospital beds, the quality of services cannot be said to be adequate.

In order to improve the health care delivery system and ensure regular supply of essential drugs, the government operates a drug revolving fund through which people contribute to health care delivery. This is in addition to the state government's Expanded Programme on Immunization (EPI), Oral Rehydration Therapy (ORT), and the Family Planning Programmes.

Electricity Supply: Presently only four towns (Jalingo, Wukari, Takum and Zing) enjoy electricity supply from the national grid. Otherwise, all other major towns in the state rely on erratic power supply from isolated generating stations under the Rural Electrification Scheme.

Water Supply: Per capita water supply in Taraba State is about 15.5 litres/day which contrasts greatly with the 25.8 percent litres/day for for mer Gongola State. This cannot be said to be good enough especially when one realises that much of the supply is either from hand-dug wells or from streams whose quality is doubtful.

The DFRRI and UNICEF, however, made significant impact in providing many towns and villages with boreholes/hand pumps to facilitate clean domestic water supply. Two medium scale water treatment plants are in operation in Jalingo and Wukari under the World Bank assisted Infrastructural Development Fund (IDF). Two other medium size water supply schemes are proposed to provide potable water in Jen and Lau.

Transport and Communications: The most important means of transport in Taraba is road transport. The system is largely run by private transporters, providing intra and inter-city taxi/bus transport services. Taraba is served by a fairly good network of roads which is however, very poorly maintained. There are a total of about 2,581 km of both Federal and State government roads in the state. Only about 776km (i.e.30.06 percent) of these roads is bitumen surfaced.

The now defunct DFRRI also constructed or rehabilitated a total of about 1,777km of feeder roads within the state to improve the connectivity and accessibility of towns and villages. These include the AbongNguroje and Serti Maisamari roads on the Mambilla Plateau. Out of these, only 776km of the roads are tar marked.

However, most of these roads are currently in need of maintenance work. Postal and telecommunication services are provided almost exclusively by the NIPOST and NITEL two agencies of

the Federal Ministry of Communication. Post and telecommunication services are essential catalysts to the processes of social and economic transformation. For a typically rural state like Taraba, postal facilities are highly necessary, especially because of the acute paucity postal facilities are also scarce.

The state has only twenty-one postal establishments, made up of twelve post offices, one sub-post office, and eight postal agencies. These facilities are located at Jalingo, Bali, Baissa, Donga, Gembu, Ibi, Lau, Serti, Takum and Wukari. Karim Lamido and Lau operate postal agencies.

Three major towns namely Jalingo, Wukari and Gembu operate automatic telephone exchange and the International Direct Dialing (IDD) System. With a total of 2,151 telephone lines, the state has a ratio of 1.45 lines/I 000 population, and ranks among the least in the country. The State Radio Corporation and the State Television (presently on test transmission) provide means of information especially to the residents of the state capital.

Tourism and Recreation: Although tourism is not yet developed, Taraba state has ample potentials for the industry. Potential tourist attractions which need greater attention from the state government and private investors include;

The Mambilla Tourist Centre: Standing at an altitude of about 1800m, the Mambilla plateau is part of the Adamawa, Obudum Shebshi and Alantika Mountain system on the eastern part of Nigeria. The rolling land surface with features of a basket of eggs and beautiful green scenery, a temperate climate and the abrupt water fall, the Mambilla tourist centre holds a lot of attractions for tourist.

Tea and Coffee and fruits like pears are grown there. The citing of the Nigerian Football Association (NFA) high altitude training camp on the plateau is a potential booster for tourism in the state. The proximity of the Mambilla Plateau to the GashakaGumpti Game reserve located at the foot of the Plateau offers a double advantage for the Mambilla tourist centre.

The Gashaka/Gumpti Game Reserve is situated at the foot of the Mambilla Plateau and covers a land area of about 6,411 sq. km. The game reserve is not yet fully developed since the roads leading to it as well as the viewing tracks are not well developed. There is, however, a catering rest house at the Gashaka Game Reserve. Species of animals found in the game reserve include buffaloes, lions, hyena, elephants, rhinoceros, and different types of reptiles like crocodiles and alligators. The waterfalls and numerous streams give further attraction to the game reserve.

The Kpambo and Fikyu Mysterious Hills: The two hills found at Kpambo in Takum LGA, and Fikyu in Wukari LGA have the appearance of a human being on top of a cave. There is also a big rock hill having the appearance of a human being wearing "agbada" (traditional flowing gown). They are believed to be legendary features and constitute tourist attractions.

The Marmara Pond: This pond, found in Wukari is also legendary. There are crocodiles in the pond It also harbours sever al white fowls which are sighted especially on Fridays. In the olden days, the crocodiles used to wander over a distance of about 1.5 km into the town unmolested.

Agriculture and Forestry: One of the most important assets of the state is the abundant arable land suitable for cultivation of a variety of both food and cash crops. In fact, it is estimated that more than forty percent of the total area of the state is arable, yet not more than forty percent of this is presently

cultivated. Crops cultivated in the state include some oil palm, coffee, tea, coconut, citru fruit, cotton, groundnut, beans, rice, maize (corn; Guinea corn, millet, sweet potatoes, yam, bambar. and other forest products.

Agriculture is, so far, the greatest employer labour with over, eight percent of the labour believed to be engaged in farming. This is made possible by the availability of richly fertile farmlands and favourable climatic conditions. The agriculture scale farm holdings. Agricultural activities are coordinated by the Taraba Agricultural Development Programme (TADP) which renders extension services to small scale farmers.

Other agencies, like the Upper Benue River Basin Development Authority and the National Agricultural Lam Development Authority (NALDA) are also engage in promoting food production, especially among small scale farmers. There are a few large scale farm projects like Abiola Farms at Dakka, T.Y. Area Takum and Cattle Ranches on the Mambil Plateau et cetera. The southern part of Taraba state is an embodiment of forest resources. Forest reserves have been established in various parts of the state, either for timber development or fuel wood exploitation. These include the forest reserves at Chicory, Gembu, Bissaula, River Amboi, Kamatan, Kurmi, Donkin, and Gongon.

Others are at Jalingo and Bakin Dutse, Gaba Chede, Dakka, River Suntai and Gongola valleys. There are several other smaller forest reserves all over the state. These forest reserves cover an estimated land area of about 1,442 sq km. Sofar.theBaissa Timber Company is the largest timber industry in Taraba State. Fishery and fish smoking activities are the major occupations engaging a substantial number of people especially in Ibi, Karim, Lamido, Lau and Ardo Kola Local Government Areas.

The Rivers Benue, Donga, Taraba and Mayo Ranewo provide sufficient opportunities for fishery activities in the state, other important basic activities in the state include poultry and nomadic cattle rearing. With over one million heads of cattle, Taraba State has sufficient raw materials for the dairy industry.

Mineral Resources: Not much is known yet about the mineral resources of Taraba State. However, the geological structure of the area suggests great potentialities. Preliminary surveys have shown the existence of large deposits of marble at Lanadu (Zing LGA), graphite at MayoButali (Jalingo LGA), gelano and barytes in Ibi and Lau LGAs, salt deposits at Akwana (Wukari LGA), lead/zinc at Arufu (in Wukari LGA) and iron stone at Jalingo.

Economic Climate: Taraba is a highly resourceful state with ample investment opportunities, especially in the areas of agriculture, agro allied industries and tourism. Much of the available resources are either grossly under-utilized or completely un-explored. This is as a result of a complex of interacting factors including weak infrastructure base, low level of technology, weak economic organisation and low level of indigenous entrepreneurship.

The economy of the state is basically agricultural. More than seventy per cent of the state's land area of 61368.6 sq.km is known to be arable, and suitable for large-scale mechanized agriculture, which the state needs seriously. The over 1.94 million people in Taraba State, who are currently served by only very few small-scale and cottage industries, constitute a potential market for any manufacturing outfit that may be established in the state.

Industrial Potentials: A sound industrial policy is an essential prerequisite for any meaningful industrial development of the state. In recognition of the important role of industrialization in the overall development of the state's economy, and the gross lack of large-scale industrial enterprises in the state, the Taraba State government has articulated an industrial development strategy aimed at creating a conducive atmosphere for sound industrial development.

Highlights of the strategy include: Developing industrial layouts fully provided with basic infrastructure, like roads, water and electricity supply in Jalingo, Wukari and Gembu (on the Mambilla Plateau); Providing land and consultancy services to investors; Providing income tax relief and pioneer status to investors; Promoting the export of basic raw materials as well as manufactured products; Promoting investment on agro-based and agro-allied industries, either through the joint efforts of the Federal and State Government, or with the private sector; and Establishing an investment company to identify and promote investments in relevant and viable sectors.

In the effort to encourage and enhance the level of economic development in the state, some key projects for which raw materials can be sourced locally have been identified for promotion by Taraba Investments and Properties Pie, taking into cognizance the availability and location of the essential raw materials in the state. These include cereals, fruit juice processing, dairy/butter, bone mill and tannery.

Others are the production of paper, toilet tissue and starch as well as cattle fattening. Already some important industrial concerns have been established in the state. These include the Nigerian Beverages Production Company, with its Tea Factory at Chicory on the Mambilla Plateau; Lau Tomato Industry (now collapsed), the Baissa Timber Development Company (now grounded) and Wukari Flour Mills (in the doldrums). There are other cottage industries like the VIVA Animal Feeds Mill at Zing, but most of these are currently also epileptic.

While much is expected from agriculture as the basis for the state's industrialization, the state has a very good potential, for the development of its tourism industry. However, as is the case with other industrial sectors, government alone cannot start and sustain a well-developed tourism industry without some degree of private sector participation. Government, however, has a duty to provide the requisite environment for private sector participation.

There is no doubt that Taraba is currently among the least developed states in the country. Its general level of backwardness in all aspects of social and economic well being can best be described as being the result of many years of neglect, insensitivity to the abundant natural and human resources, planning and lack of good governance that characterized previous administrations in the state.

It was common for every government in the past to characterize the state as "the food basket" of the country and as a serious embodiment of resources. Yet, there has never been any serious commitment on the part of any government so far, to properly study, understand and plan for the development and exploitation of these acclaimed resources. Perhaps the worst that has happened to the state in terms of development is the total neglect of the educational sector.

This means a near total abandonment of the state's human resource potentials, as reflected in the high levels of illiteracy and school dropouts. The development of the state's natural endowment is necessarily contingent on developing its human resources. No industrialist would invest in an area that

is grossly lacking in skilled labour. Moreover, the high level of illiteracy rivation among the state's population who otherwise would provide the potential market for any local industry.

The future economic development of the state lies, not so much on how many trade fairs and exhibitions the Taraba state government would participate in to expose its investment potentials, or on how much it spends to establish industrial layouts as incentives to investors. Rather, the state must plan more seriously, with all sense of commitment, towards the educational development of its overwhelmingly youthful population.

The state may compromise anything but not the development of its human resources. Perhaps, beyond investing in education and agriculture, the investment climate in Taraba state also favours the development of the tourism industry. This is possible only if there is serious commitment on the part of the government to participate directly and encourage the involvement of both local and foreign private investors.

This is one area where the state has a good comparative advantage for its future economic growth and development. Spatial and gender inequalities that are manifested in the state's development process should also be the focus of government planning strategy in the new millennium.

This requires a more aggressive policy that encourages local participation in matters of development that directly affects the people's lives. Through organs such as co-operative unions, development associations and other non governmental agencies, advice can be given to the local government council and the state legislature on issues of development and people's wellbeing.

2. SECTORAL ANALYSIS AND FINDINGS

2.1 Education Sector (Baseline information and Needs identified)

2.1.1 Performance in achieving the MDG in the sector

According to the respondents, Taraba State has made some measure of efforts towards attainment of MDG Goal 2 on universal basic education. However, most of them reported that these efforts are not enough for the realization of contents of this goal by the year 2015. These efforts were reported in the areas of provision of UBE infrastructure, building of class rooms and re-training of teachers. The general performance rating of the state by the respondents stands at 35%.

Respondents pointed out that effort of the State government in improving the education sector is almost and consistently cancelled out by poor funding of the sector, lack of commitment by relevant stakeholders and neglect meted to effective funding of MDGs projects in the state.

2.1.2 .State government's policy and implementation frameworks

Presently, Taraba State government has a policy covering primary and post-primary education in the state. Contents of this policy as it relates variously to these educational institutions provide for compulsory education for every child in the state, school uniforms, text books, sitting desks and tables for the children and tuition-free secondary education. Summarily, these tend to achieving education for all by year 2020. Majority of the respondents agreed that activities and frameworks to achieving these contents are enshrined in the policy document but implementation is what is lacking in the state.

However, a few of the respondents reported on the negative that the State government has no policy on primary and secondary education.

2.1.3 Teaching and learning environment in schools within the State

Opinions of respondents vary on prevalent student-teacher ratio in schools within Taraba state. However, the result shows an average of 51 pupils/students to 1 teacher in most primary schools in the state, 53 students to a teacher in most secondary schools in the state and 110 students to 1 lecturer in tertiary institutions in the state (especially in the first academic years). These numbers of primary schools pupils and post-primary schools students also represent the numbers found in their various classes.

In terms of distribution of education facilities in Taraba State, majority of respondents reported that the facilities are not equitably distributed against the insignificant few that reported equitability in facility distribution within the state. (See the bar-chart below).

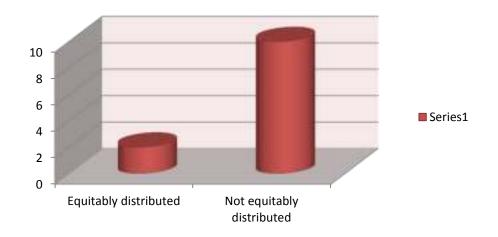


Chart 1: Pattern of distribution of education facilities in Taraba State

According to the respondents, the distribution pattern has remained lopsided. While a few local governments have appreciable number of educational institutions, some others do not have adequate number to serve the population obtained in such areas.

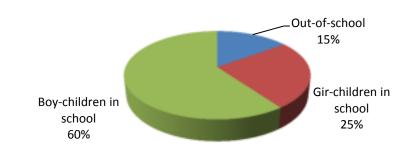

Majority of respondents reported a wide disparity between boys and girls that attend schools in Taraba State. The presentations show that the ratio stands around 3 boys to 1 girl. According to their reports, it is appalling and a course for concern that up to 15% of school age children in the state do not attend school.

2.1.5 Critical needs in education sector

Identified needs required in education sector of Taraba State as provided by respondents are highlighted in the table below;

2.1.6 On-going intervention projects of State/Federal government towards meeting identified needs in the sector

The respondents listed out some of the State government's current efforts towards addressing some of the needs identified above. These include the following;

- The Education Trust fund (ETF) project through which the primary and post-primary schools in the state are funded for infrastructural and instructional facilities.
- Tertiary Education Trust Fund (TETF) for projects interventions in tertiary institutions.

According to the respondents, these present interventions of government (state and federal) suffer ineffective management in areas of implementation, supervision and monitoring. Therefore, results so far are far below expectations in addressing the needs identified in the sector. Two-third of the respondents knows that a policy for improvement of educations sector exist in the state but do not know the contents of this policy while one-third are not in the know concerning the state government's plan for future development of the education sector in Taraba.

2.1.7 Partners intervening in education sector

The respondents identified the following institutions as active partners with Taraba State government in development interventions within the education sector;

2.1.8 PPP framework in the sector

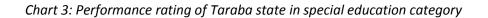
According to reports of the respondents, there are a number of projects initiated and implemented by the Public-Private-Partnership (PPP) framework in Taraba State in the education sector. Some of these include;

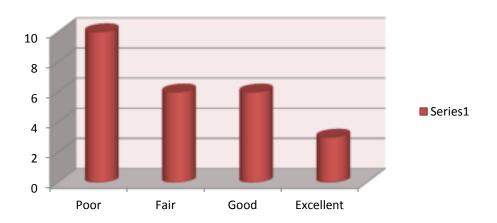
- Provision of computers in several schools in the state in partnership with Zenith Bank PLC and some Non-Governmental Organizations.
- Agency for communities social development projects piloted in communities
- Partnership of Elimus Limited in building of primary schools
- Partnership with TY Danjuma Foundation in building of class room blocks and bus stops for schools.

However, more than 80% of the respondents are unaware of existence of any official policy on PPP in Taraba State.

2.1.9 Performance rating of the state in special education category

The special education category comprises educational provisions and interventions for the handicapped, blind, deaf, dumb and special children. This also comprises all forms of informal education for nonliterates and adults in the state. The chart below represents the submissions of the respondents in the study.



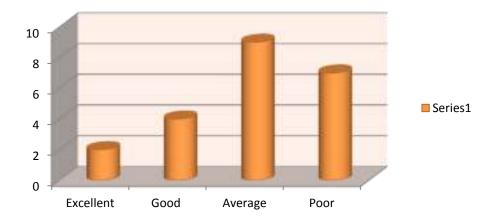


Quite a good number of the respondents attested to the fact that that Taraba State government is not doing well in the area of special education. This calls for a step-up of activities along this direction. The state of non-formal education for adult literacy in the state was also adjudged poor by a good number of respondents.

2.0 Health Delivery (Baseline information and Needs identified)

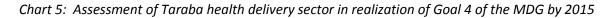
2.2.1 Performance rating of health services in the State

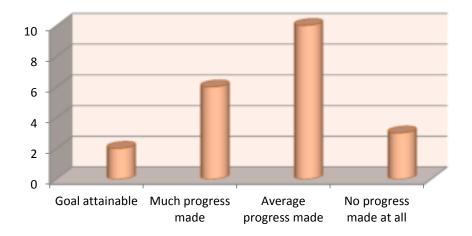
Chart 4: Overall performance rating of health delivery services in Taraba State.



Majority of the respondents adjudged performance of the State in terms of health delivery as average. Though, there is no significant difference between the number that reported the performance as average and those that reported it as poor, the situation on ground in the state pertaining health delivery, shows that a little has been done by the state government and some partners towards improving this sector. However, there is much left to be done in the sector if the Millennium Development Goals related to it will ever be achieved. This is the mind of all respondents including the few that rated health delivery services in Taraba State as either good or excellent.

2.2.2 Performance in achieving MDGs in the sector

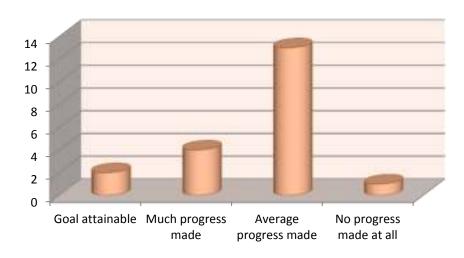




Goal 4 of the MDG targets reduction in infant mortality. More of the respondents reported that some level of progress have been made in the State in the area of putting structures of primary health centres on ground in some local government areas. A few of the respondents, but significant to be ignored, reported that nothing has been done so far in the state (at least visible to be recognized) towards meeting this goal. However, a very insignificant number of respondents believe that goal 4 of the MDG is attainable by 2015 in the state.

Goal 5 of the MDG targets to achieve improvement of maternal health. Although almost all the respondents were of the view that some levels of progress have been made in the state along this line, more of them reported that these levels of progress have not gone above average. They reported that there is a weak implementation of policies meant for granting free health services for pregnant women in the state. This according to the respondents are practically absent in reality in most health centres in the state.



Some of the respondents blamed the situation on the sordid state of most health facilities in the state especially in the rural areas where there are either no infrastructure or drugs. In the centre of this situation, very few of the respondents believe that the goal can still be attained in the state within stipulated time frame of 2015 only if there are aggressive interventions to improve on what currently obtains in the health delivery sector of the state. This number is significantly higher than those who reported that no progress at all has been made in the state towards realizing this goal.

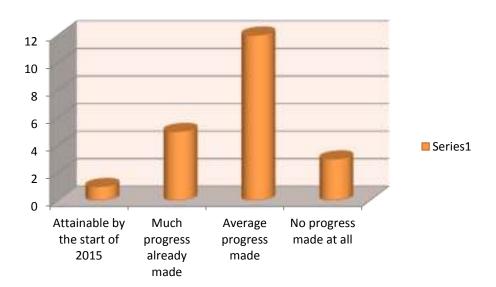


Chart 7: Assessment of Taraba health delivery sector in realization of Goal 6 of the MDG by 2015

The target of Goal 6 of the MDG is to combat HIV/AIDS, malaria and other diseases. In Taraba state, majority of the respondents attested to the fact that an average progress has been made so far by the state government and its partners along this direction. However, an appreciable number believe that much progress has been made especially by non-governmental institutions working in health in the state. This a significant difference from those who reported of no progress made at all. The people

complained about inadequate intervention made so far by various stakeholders against the prevalence of onchoceriarsis in various parts of the state, especially in rural communities. Given the situations above, a very insignificant number of the respondents believe that the goal is still attainable by the start of 2015.

2.2.3 Problems identified in the sector

A number of constraining challenges were identified by respondents as limiting expected progress of the health sector in Taraba State. These problems are captured in the table below;

2.2.4 Health delivery environment in Taraba State

According to the respondents, Taraba State with an approximate population of 2.4 million people, lack coordinated emergency response services in the health sector. It was reported that the entire Taraba State has only 4 operational ambulance vehicles that are all stationed in Jalingo. The patient to doctor ratio stands at 20,000 patients to 1 medical doctor (a situation which is sub-standard to an ideal health system that is working). This statistics is so because the total number of medical doctors reported in the state is 112.

The State has only 2 tertiary hospitals (Specialist hospital Jalingo and Federal Medical Centre (FMC) in Jalingo as well). Out of these two, it is only the Federal Medical Centre that is functioning. Therefore, it is most practical to say that the entire population of the state is being served by only one tertiary health institution. It is not all the Local Government Areas in the state that have about 2 health centers to serve the people. This is the case of Gembu, Warwar, Bali, Zing, Bambur and wukari LGAs.

In most of these health institutions, basic utility supplies to aid effective service delivery are very ineffective. In virtually all the institutions especially those outside the state capital (Jalingo), almost all solar-powered and manual (motorized) water borehole facilities are no longer functioning. Also, generators in all these health centers except Specialist hospital and Federal Medical Centre are bad. This affects quality of services in these institutions.

Given the scenario above, patients diagnosed with critical illnesses are referred to other health institutions outside the state including; ABU Zaria, Jos TH, Maid TH, UNBTH, UCH, Kano-BUK TH

According to the respondents, Taraba State ranks second in the country in HIV prevalence. This is a situation that calls for closer attention by all development stakeholders. Monitoring and Evaluation framework existing in the health sector of the state was largely described by the respondents as very weak and uncoordinated.

2.2.5 Critical Needs in health sector

Relative to the problems identified in the sector, the following needs represented in the table below were identified during the survey

2.2.7 On-going intervention projects by state and federal government towards meeting identified needs in the health delivery sector of the state

Majority of the respondents reported that the government is doing one or two things in the state in response to the health needs of the people. According to them, these include measures that the state government in collaboration with other development partners, are putting in place to address the numerous challenges of disease prevalence across communities in the state. These tilt towards preventive health care services to provision of infrastructure. However, the later is at the minimal. An appreciable number of the respondents also reported that the government is not doing any tangible program in the health sector that can be seen. A few others are not sure if the government is currently doing anything or not in the sector.

2.2.8 Partners intervening in the sector

Some organizations identified by the respondents as partners in projects within the health delivery sector in Taraba State are listed in the table below;

Other potential partners whose works will be needed in the health delivery sector of the State, and as identified by the respondents are MSH and a host of health-related NGOs including Bill and Melinda Foundation, TY Danjuma Foundation. According to the respondents, the PPP framework has not been optimally explored in the state to improve the lot in health delivery services.

2.2.9 State government's policy and implementation framework in the sector

However, almost all the respondents reported that implementation of these policies by the State government is very weak. A few reported that they are not aware of the existence of these policies as there are hardly any medical services in these institutions that does not go with pay from the people.

2.3 Cottage Industry support (Baseline information and Needs identified)

2.3.1 Performance rating of Taraba State in cottage industry sector

The performance rating of Taraba state by the respondents on the basis of development activities in the cottage industries support is shown in the bar-chart below;

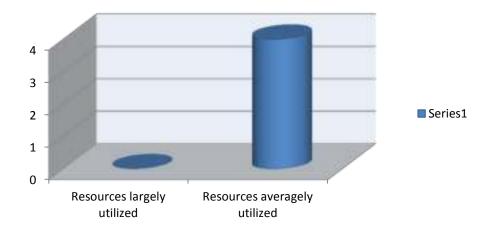


Chart 8: Performance rating of Taraba State in cottage industry sector

Majority of the respondents reported that the state is not developing industrially. This is in contrast with the report of an insignificant few that viewed Taraba State as recording good level of progress in terms of industrial development. The former hinged their responses on the fact that despite the huge number of solid mineral deposits available in the state, not much has been done to harness them for industrial use. In addition, there are few SMEs in the state over the years now which has scaled-up unemployment rate in the state.

2.3.2 Major Industries in Taraba State and their status

In agreement with the submissions above, the respondents identified a few number of industries currently existing in Taraba State. Some of them are owned by the State government while some others are privately owned. The table below captured the submissions of the respondents;

Raw materials used by most of these industries range from agriculture, timber to solid minerals that exist in the state. The companies also vary in size and structure. Some were classified by respondents as 'Medium' and some others as 'Small'. The table below shows some categories of industries in Taraba State existing in the small and medium scales of operation;

However, it should be noted that the industries captured in the tables above do not represent all industries operative in Taraba State. The declining trend in the number of SMEs being established in the state over the years till the present (as reported by majority of the respondents) was blamed on a number of factors among which are poor funding, government's insensitivity in developing the subsector, inadequate storage facilities, exploration of adequate raw materials, inadequate market, systemic corruption in governance and administration of the sub-sector as well as ineffective power supply among others. An insignificant number however, reported that the trend is increasing but not as expected.

A combination of these factors, has variously led to wounding up of some industries in Taraba State among which are;

- Habo fair floor mill (in Wukari)
- Baissa timber COY (in Baissa)
- Vivah animal feed mill (in Zing)
- Taraba sugar industry (in Law)
- Kaolin fertilizer COY (in Jalingo)
- Gongola timber (in Baissa LGA)
- Mko abiola farm (in Dakka-bali LGA)
- Wood & furniture industry (in Jalingo)

2.3.3 Industrial-based natural resources in Taraba State

Taraba State has quite a number of natural resources to leverage on for growth in the state. These resources as represented in the table below, are classified into solid minerals and agricultural products.

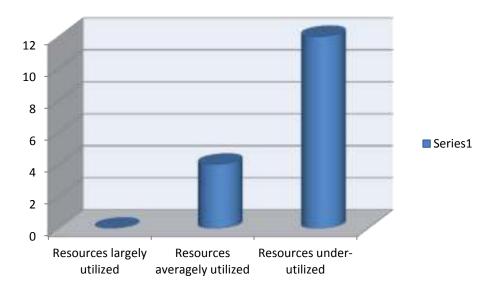

Generally, the State is endowed with water resources and arable farm land.

Extents of utilization of these resources vary from one category of resource to the other. Agriculturalbased resources are more utilized compared to solid minerals that are grossly under-utilized at the moment. Submissions of the respondents on extent of development and utilization of available natural resources in the state are reflected in the chart below;

Chart 9: Natural resource development and utilization in Taraba State



Majority of the respondents reported that these resources are under-utilized at the present. However, few respondents reported that natural resource utilization in the state stands on the average. The former established the fact that under-utilization as reported by them applies to both categories of natural resources obtained in the state (agro-based and solid minerals). None of the respondents reported that these natural resources are optimally utilized in the state. Generally, all the respondents believe that this low resource utilization largely accounts for little or no growth of SMEs in the state at the moment.

The respondents were of the view that the situation in this sub-sector will improve if the government becomes sincerely committed to developing the sector, enabling environment are allowed for local and foreign investors in the state, much aggressiveness is given to PPP framework in the sector and technology transfer is encouraged for high-tech industrial activities among others.

2.3.4 Policy and implementation framework on resource utilization

More respondents reported of not having any knowledge of policy frameworks existing in the state to guide resource utilization in the sector. This is against the number that reported awareness of existence of such a policy in the state. However, it is an insignificant difference scenario between these two categories of respondents.

For the later, this policy framework was reviewed in 2000 by a Russian firm.

2.3.5 Problems constraining cottage industries growth in Taraba State

Some key factors limiting the growth of cottage industries in Taraba State as identified by the respondents are showed in the table below;

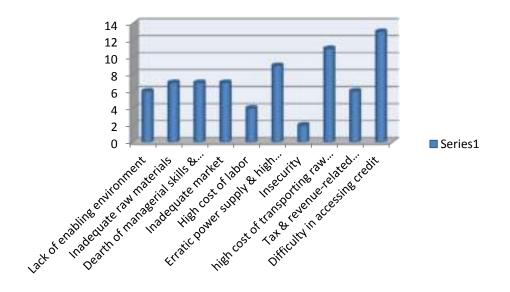

These factors have been neutralizing what would have been gains from the conducive nature of Taraba State to industrial investment and growth.

Submissions of respondents on key constraining factors limiting growth of cottage industries in the state is reflected in the chart below;

Chart 10: Key factors limiting growth of cottage industries in Taraba State



According to respondents' submissions, difficulty is accessing credit facilities ranks highest among the constraining factors identified. This is closely followed by high cost of transporting raw materials from source to sink probably because of bad road networks. Erratic power supply leading to high cost of production ranked third and closely followed by inadequacy of raw materials, inadequate market and dearth of managerial skills and competent staff. The least in the ranking is insecurity after high labor cost, tax and revenue related problems as well as insufficient enabling policy environment.

2.3.6 *Critical Needs of the sector to grow cottage industries*

The respondents identified the following needs (see table below) in the cottage industry support;

These needs covered broad areas of funding, manpower, equipment and entrepreneurship development programs.

2.3.7 Development partners in the sector

The respondents identified a number of development partners in the cottage industry sub- sector of Taraba State and their activities in the partnership. These include;

- UNDP (has been assisting the State government in training of staff)
- African Development Bank (ADB) (contributes in development of agriculture and agro-based activities)
- World Bank (assists in FADAMA II and III programs under agriculture and cottage industries support).

According to majority of the respondents, the banks and other financial institutions in the state are moderately assisting SME operators in the state. However, almost the same number of respondents reported that the financial institutions have not been helpful to SME operators.

2.4 Economic Empowerment for women (Baseline information and Needs identified)

2.4.1 Main Livelihoods Sources for women in Taraba State

As identified variously by the respondents, most women in Taraba State are in to petty trading, farming, civil service, sewing and tailoring, livestock and poultry farming as well as knitting and weaving as their main economic mainstay. However, a few of the respondents added that pottery is inclusive in this category of income-generating skills among the women of the state. There are other minor livelihoods support activities taken up by the women in the state which are not captured by the respondents.

2.4.2 Unemployment among women in Taraba State

The respondents were unanimous in rating incidence of women unemployment in Taraba as high as 65% because of the soaring number of idle women who virtually do nothing but depend wholly on their husbands and relatives for livelihoods. This scenario according to the respondents is caused by a number of constraining factors as identified in the study. Some of these factors are gender-specific while others are generic.

Some of these identified factors include; dearth of capital to start businesses for self-reliance, lack of financial support from the government, illiteracy, inadequate training facilities and resource center for

women to acquire skills, unfavorable customs, traditions and religious laws against women, inadequate number of cottage industries to engage women, little or no economic empowerment programs for women, ignorance among women on the importance of education, laziness of some of the women, constraining gender roles and low political participation by women among others.

This increasing unemployment situation among women of the state has resulted to a lot of illconsequences as identified by the respondents. These include; prostitution, stealing, high rate of divorce, over-dependency on men folk, high poverty rate, drug trafficking, drug Abuse, improper upbringing of children in female-headed families, child trafficking and child labour among others.

2.4.3 Identified needs for women economic empowerment

The following were identified by the respondents as needed in order to improve on the lot of the women in Taraba State economically;

According to the respondents, the establishment of vocational training centres for women across the state should focus on skills and trades that most women can do including (in order of preference);

- Tailoring and sewing
- Knitting
- Hair plaiting and dressing
- Catering
- Soap-making
- Farming
- Aquaculture
- Petty trading
- Computer operations/business centre management
- Pottery
- Interior decoration
- Confectionery making
- Bead making
- Palm oil processing
- Tie and dye

The respondents reported that entrepreneurial skills training should complement these technical skills acquisition as necessary elements of effective business set-up and sustainable economic empowerment of women in Taraba State.

2.4.4 Skill Acquisition Training Centers for women in Taraba State

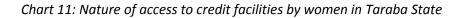
According to the respondents a lot of these institutions are not functioning effectively. Reasons were given behind difficulties encountered in the state against the realization of set objectives for establishing these SAT centres. The reasons include;

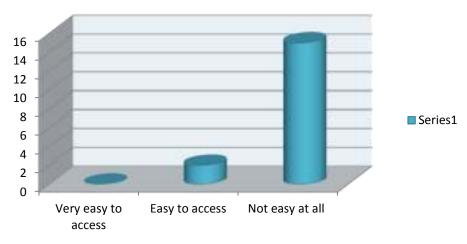
- Inadequate funding of such institutions
- Lack of commitments from institute managers

- Poor infrastructure
- Inadequate awareness of existence of these institutions in the state
- Managerial incompetence
- Wrong attitudes of people towards utilization of these resource centers
- Systemic corruption in governance
- Little or no support from the government
- Un willingness of some women to use such facilities
- Uncoordinated private-public partnership.
- Lack of business capital for set-up of graduates from these centers
- Functional inconsistency etc.

2.4.5 Access of women to credit

The presentation from the respondents on ease of access to credit facilities by women in Taraba State is shown in the chart below;





A significant majority of the respondents reported that it is pretty difficult for women to access credit facilities in Taraba State to improve on their livelihoods system. As a way of improving on the current situation, the respondents gave a number of recommendations which include the following;

- Government to come to the aid of the women by granting them micro-loans for micro-business start-up.
- Procedures for accessing such loan facilities should be simplified for the women
- Favoritism and bias should be discouraged in any credit scheme in the state
- Government to create enabling environment for commercial banks to operate in order to reduce their lending rates to the poor especially women
- Proper enlightenment of the women on where to access these funds and how to access them.

- Creation of more credit centers, frameworks
- Institutionalization of efficient regulatory mechanisms

Some formal and informal financial institutions whose operations in the state are relevant or may be relevant to women's access to credit as identified by the respondents include;

- Taraba saving

- Dudulahi

Summarily, more than 86% of these institutions that provide micro-loans to women in the state belong to the informal category. It was the popular view of almost all the respondents that activities of these informal institutions can be supported by the government and other development partners for required scale-up of coverage and reach.

In the light of the above, all the respondents agreed that forming women groups like cooperative societies and other economic groups has proven helpful to attracting and distributing micro-loans to women. They therefore called for visible incentives from government to encourage formation and registration. However, an insignificant few of the respondents reported that women groupings have not been helpful in easing access of credits to them. This they blamed on systemic corruption in such groups, polarization along political party differences as well as lack of confidence and trust among members.

Identified partner organizations working to improve economic status of women in Taraba State include; Shishiam Women Development and TY Danjuma Foundation. 2 (CAN Women Wing, united Methodist church in Nigeria) remains an identified Faith-Based institutions partnering in this sub-sector in the state.

2.4.6 Governments projects to empower women in Taraba State

The following were pointed out by the respondents as key government efforts towards empowering women of Taraba State economically;

- Support to adult education in some parts of the state
- Entrepreneurship training and

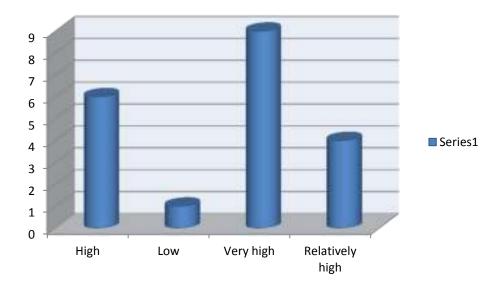
2.5 Economic Empowerment for Youths (Baseline information and Needs identified)

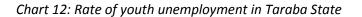
2.5.1 Population overview of youths in Kwara State

The respondents vary in what they presented as estimated population of youths in Taraba State. The three figures presented were ({801,000}, {1,787,794} and {1,000,000}). Out of these estimated population figures, an average of 45% are within school-going age while 55% are of working age.

2.5.2 Youth unemployment in Kwara State

The views of the respondents vary in the rate of youth unemployment in the state. These are represented in the chart below;





From various submissions of the respondents, it is obvious that unemployment is adjudged very high among youths in Taraba State. According to them, many youths roam the streets doing nothing to earn their living either on paid employment or self-employment. An insignificant number of respondents still believed the contrary, and reported that rate of youth unemployment in the state is low. The former

category of respondents gave reasons for reporting a high to very high incidence of youth unemployment in the state. These are shown in the table below;

The respondents were quick to point out some critical consequences of this unpleasant situation in the state. These include; thuggery by youths especially during political activities, increased crime rate, prostitution, threat to peace in the state, declining GDP, dwindling proceeds from taxes, poor standard of living, drug abuse /addiction, waste of resources, youth violence, theft/ robbery, assassination and other forms of Killing, social stress and tension, touting, increased dependency and increasing number of dependants in the society, militancy (e.g 'Boko Haram' incidence), incessant communal crises and reduced productivity.

2.5.3 Policies and frameworks in place to address youth unemployment in the state

A good number of the respondents reported that there are some measures the state government has put in place towards addressing growing incidence of youth unemployment in the state. The frameworks are derived from existing SEEDs document in the state which feeds into the NEEDs document. These frameworks are shown in the table below;

Among these interventions identified by the respondents as government's efforts in responding to the challenges of unemployment in Taraba State, some of them that have succeeded to reasonable extents include training on self employment, the NDE framework, procurement and distribution of commercial tricycle (keke NAPEP) and motor cycles to youths, the FADAMA programme, the cassava expansion programme, the poverty alleviation programme, reformation of system of education in the state and the National Open Apprentice ship scheme.

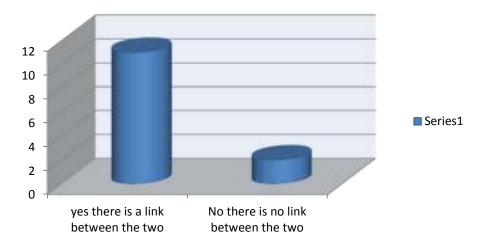
The E-Wallet (GESS) programme and some parts of the poverty alleviation programme were adjudged failed by the respondents.

The respondents suggested replication of some projects that have succeeded elsewhere in Taraba State. These include YOU WIN" programme of the Transformation Agenda of the Presidency, free education in Imo state and technical skills acquisition introduced by Murtala Nyako in Adamawa state in 2008.

2.5.4 Youth unemployment and education type

The chart below shows the views of the respondents on the relationship between education type in the state and present rate of unemployment among youths;

Chart 13: Relationship between education type and youth unemployment in Taraba State



It is the report of critical majority of the respondents that there is a link between education type practiced in Taraba State and the present rate of youth unemployment in the State. They pointed out that the main objective of integrating vocational courses into current curriculums of secondary schools in the state is to improve skills and employment opportunities of these young ones as they are completing their academic work in post-primary schools. Compared to the number that reported a link between education type and unemployment increase in Taraba State, an insignificant number of respondents reported that no relationship exists between the two variables.

The respondents suggested what should be done in order to create healthy and productive link between education type in Taraba State and employment rate. These include; enforcing the implementation of vocational courses integrated in schools curriculums, creation of opportunities by the government and philanthropists on human resources and entrepreneurial development, revising and improving the educational system, creating more schools, effective funding of the schools, implementation of free education policy in the state, improving entrepreneurial and technical skill-base of the youths, awareness creation among youths towards realizing what they can do to become self-employed, encouragement of SMEs in the state,

2.5.5 Identified skill gaps among youths in the state

The respondents identified some skills that are inadequately covered among the youths for optimal empowerment. These skills include the following;

The respondents were unanimous in adding that vocational skills acquisition, entrepreneurship and creativity are inseparable needs towards achieving sustainable employment for the youths.

Majority of the respondents reported that these institutions are all functioning. Some others reported that they are not functioning. However, some of the factors which they reported as constraining the achievement of objectives SAT centers in the state include the following;

- Dearth of motivation to the institutions and the youths
- Dwindling literacy
- Lack of empathy from the youths
- Poor funding
- Faulty policy
- Systemic corruption
- Ignorance on the path of unemployed youths (they do not utilize what was given them to trade)
- Poor management and incompetence
- Government is not making any effort to establish skill acquisition centers
- Mismanagement of funds made for development of such institutions
- Inadequate motivation for trainers/instructors in the centers.
- Lack of trained resource personnel
- Lack of institutional framework
- Peoples' attitude towards government

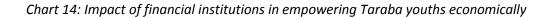

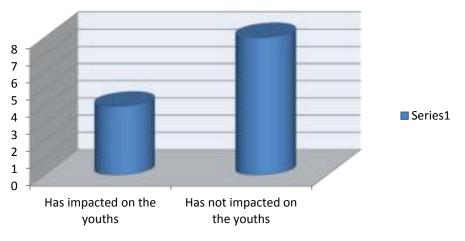

2.5.8 Impact of financial institutions to youths' economic empowerment in the state

The chart below presents the submissions of respondents on how impactful financial institutions have been in assisting the economic empowerment of youths in Taraba State.





Majority of the respondents attested to the fact that the financial institutions have not impacted visibly on economic empowerment of the youths in Taraba State. To improve the situation (especially of access to credit facilities by youths from these institutions), the following were suggested;

- Adequate credit portfolio should be made available for the youths to access
- Formation and support of Youth cooperative societies and other economic groups should be encouraged with such loan facilities.
- Government should improve partnership with these financial institutions in this responsibility.
- The financial institutions should make simple procedures and criteria for accessing these loan facilities for the benefit of youth micro-entrepreneurs.
- Government should assist by providing short and medium term loans
- Unemployed youths should prepare and present their business feasibility study report in order to access loan from banks. Their technical and entrepreneurial capacities should be developed along this line.

- Banks and other credit unions should provide a continuous opportunities for capacity building for youths
- Interest charges on such loans to the bearest minimum

2.0 General Analysis Of Findings And Recommendations

This analysis is made on the basis of data from gathered from both primary and secondary research sources. It is sectionalized into various sectors studied.

Taraba State inherited very few indices of development from former Gongola State. Till date, the state lack most social infrastructures and has remained one of the least developed states in Nigeria. It has been in this situation not because it lacks the needed natural and human resources to develop but because of improper planning, improper implementation, improper monitoring and evaluation as well as misapplication of scarce resources especially by past governments (as reported by both the secondary and primary sources)

Education

Taraba State's efforts in the area of health delivery are currently on the average rating (judging from the field respondents and desk research gathered). These reported efforts are geared towards achieving goal 2 of the MDG which is compulsory basic education for every child in the state. Therefore, trickles of interventions in areas of training and re-training of teachers, building and renovation of classrooms and supporting the UBE policy framework have been on-going in the state. However, the present magnitude of these efforts still remains a far cry to actual challenges facing the development of the sector. Part of the constraining factors identified is poor funding of activities of the sector and little or no commitment from the government

There is a perfect agreement between the secondary and primary data on the general evaluation of teaching and learning environment in the entire Taraba State. It is clear that the number of schools in the state are grossly inadequate compared to the huge population of people distributed across 16 LGAs and 18 districts areas of the state. Record has it that there are 986 public primary schools and 109 secondary schools in the entire state. In terms of distribution, it reflects very high spatial inequality. While some LGAs are having more, some others have very few of these schools. The extreme cases are Saduarna LGA that has 132 primary schools and Ashaka that has only 16.

The student-teacher rate is one of the highest in Nigeria and illiteracy rate is increasing on a progressive trend. Other critical findings in the study in this sector are highlighted below;

-The state government has good policy document and implementation frame work in the sector but lack objective implementation of same.

-There is observed disparity between boys and girls of school-going age attending schools in the state. This favours the boys who outnumber the girls by the ratio 3:1

-The sector needs human resource development as well as physical and social infrastructures.

-Private partnership in the sector needs to be strengthened the more since it is obvious that the government cannot handle the challenges alone nor sustain the gains on its own. Opportunities exist for such synergy building in the state as some external agencies and development institutions have interest working with the state.

-The State is performing below average in the area of special education.

Health Delivery

Taraba State government and some development partners have been making some efforts towards achieving goals 4 (reducing infant mortality), 5 (improving maternal health) and 6 (prevention of HIV/AIDS, malaria and other diseases) of the Millennium Development Goal (MDGs) but the entire efforts so far have been rated average in terms of performance.

A major environmental health challenge in the state is the incidence of River blindness (Onchocerciasis) majorly prevalent in Gashaka, Bakundi and Gasol districts with its socio-economic consequences on the people, taking a toll on the productive age groups of the population, reduction in economic productivity, secondary school enrolment/attendance and displacement of whole communities among others.

In the face of this challenge and others, the sector is faced with unpleasant situations as highlighted below;

-Health facilities in the state are inadequate (the functional government-owned general hospitals cannot serve the 2.4 million population of the state). In addition the number of medical establishments across the 16 LGAs for maternal and primary health care services at the grassroots are not only inadequate to serve the population, but are inequitably distributed.

-Patient to Doctor ratio is high. It stands at 20,000:1. This is a deviation from the ideal ratio of 1,000: 1. This justifies the call by the people for more medical staff in the system.

- The sector is under-funded by the government, the health institutions lack basic health equipment and adequate drug supply. These constrain effective health delivery system in Taraba State.

-There is observed disparity in health care interventions between the urban and rural parts of the state which needs to be bridged towards achieving balanced development in the sector.

Cottage Industry

In Taraba State, industrial investments are grossly lacking. Rural and urban market is poorly developed as well. The State and other external institutions have not done much in the area of cottage industries support leaving the sector undeveloped. Critical findings from the study are highlighted below;

-There are very few cottage industries in the state despite the huge market offered by a whopping population of about 2.4 million people.

-There are ample investment opportunities in this sector especially in agriculture and agro-allied industries

-The geological structure of the state suggests great potentialities in solid mineral resources.

-There is an industrial policy in the state, but this lacks proper implementation at the moment

-Under-utilization and under-exploration of resources available in the state accounts largely for the slow industrial development of the state.

-Private sector participation in this sector is still weak. This needs to be strengthened because the government cannot start and sustain this.

-Development of human resources by way of education and handing over of technical skills is critical in the development of this sector.

-Industrial growth in the state is constrained by other factors identified as systemic corruption, inadequate credit facilities for potential SME operators, poor feeder road networks in the state, dearth of requisite technical skills and unreliable power supply.

-Generally, the state is conducive for investors.

Economic Empowerment of women

Much needs to be done in Taraba State to empower the women economically. Efforts of the state government via the Ministry of women Affairs have remained skeletal and quite inadequate to address the challenges of sustainable empowerment of women in the state who are increasingly becoming unemployed and poor in the society.

The following constitute critical findings of the study as it relates to this sector;

-Illiteracy rate among women of the state is among the highest in the country (about 75.1%)

-There is observed gender inequality in the state's development process. Development affairs of women should be taken more seriously in the planning strategy of the state government.

-Local participation of women in development process is still low in the state (especially at the grassroots). This contributes to their low economic status. Therefore, aggressive policy to encourage strengthened participation is needed to stem the tide.

-The rate of unemployment among women in Taraba State is very high. This is as a result of a number of factors including poor government's support, difficulty faced by the women in accessing credit facilities,

dearth of technical skills, unfavourable traditions and laws against women and fewer numbers of cottage industries to engage them.

-Technical and entrepreneurial skills development, good access to credit and creation of more opportunities of employment via establishment of more cottage industries, support of education of girl-children and adult women as well as improved political participation of women are needed in the course of empowering the women economically and socially in Taraba State.

- The number of Women Development Centres in the state is grossly inadequate.

Youth Economic Empowerment

Taraba State has a great chunk of its population made of youths. Out of this huge segment of the population, it is only an estimated 22% that are productive. The others are virtually doing nothing to help themselves or the state. This under-pin the challenge the state has to invest heavily on providing for health, education and economic development of this group.

The rate of youth unemployment in Taraba State is quite high. This situation is as a result of a combination of factors including poor orientation among the youths on their ability to become self-employed as well as dearth of livelihoods support skills.

Critical findings of the study related to this sector are highlighted below;

-The overall performance of the state in this sector is average in rating

-Existing SAT centres are not adequate enough to serve the youths in the state. Therefore, more of these centres should be built in the state and existing ones upgraded and adequately equipped to function effectively well.

-Integration of vocational courses into academic curriculums of the state is not receiving proper implementation. These need to be enforced adequately

-Entrepreneurial youths in the state lack access to credit facilities for effective enterprise set-up upon graduation. They need to be supported financially along this direction.

-Generally, core aspects of youth empowerment in the state should involve vocational and entrepreneurial skills supported with credit facilities to enable businesses set-up.

4.0 Validation workshop

To promote participation and ownership of the process leading to the evolution of a 5-year development plan and concept notes for Taraba State, a one day workshop was organized in the state on.. at the conference hall of Taraba State University, Jalingo.

A summary of activities at the workshop include:

- Presentation of identified critical needs of the sectors
- Validation of findings
- Prioritization of identified sectoral needs at the plenary
- Selection of 5-7 critical sectoral needs for action plan development
- Development of action plan for each of the sectors
- Evolution of a 5-year development plan for the state
